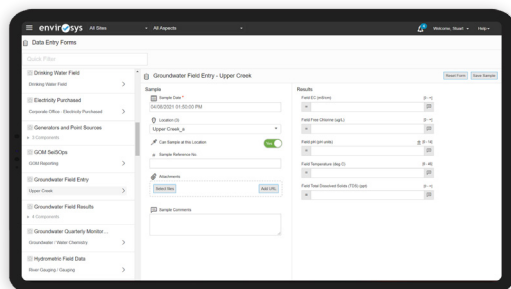
The latest release of EnviroSys, version 8.5, delivers a number of enhancements and improvements to your environmental data management software.

It includes:

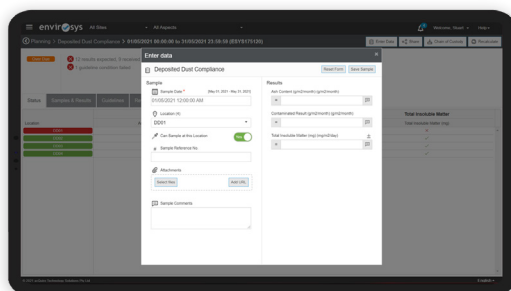
- ✓ The option to use Data Entry forms and enter data all within the one interface.

Dynamic data entry

EnviroSys 8.5 gives you the ability to enter your environmental data directly into Data Entry Forms within the main EnviroSys interface. You can now work without the need to switch interfaces. Dynamically generate Data Entry forms from your saved Data Views or from scheduled runs in Sample Management.



Access data entry forms from the main menu (top left) and enter data including the ability to attach files to the sample.

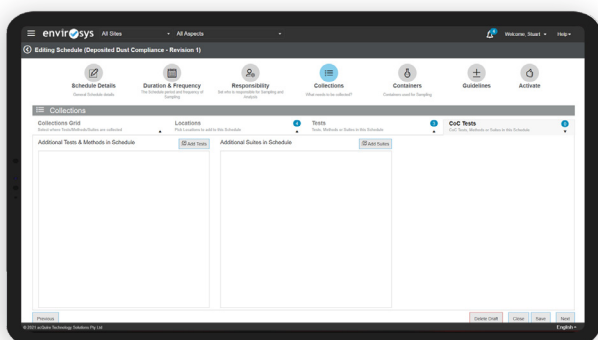


Dynamically build forms from a schedule based on the locations and test methods which are expected to be collected according to the schedule's rules.

More Chain of Custody and schedule options in sample management

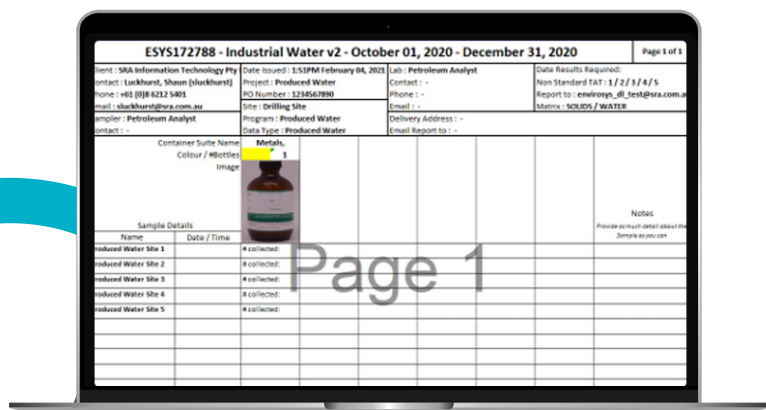
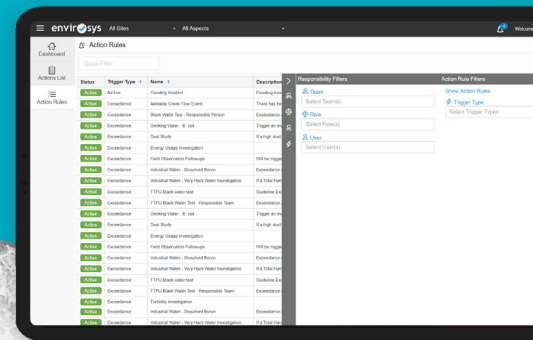
Sample Management now contains more Chain of Custody (CoC) formats, adding to the options introduced in our previous release. You can now use the following:

- **Additional CoC Test Methods** – You have the flexibility to add test methods to a schedule which are not included in the sampling run statistics but are included on the CoC.
- **Substitute Location** – You have the option to allow all substitute locations to be displayed as well as the planned location on the CoC.



Additional action management options and filters

We've listened to your feedback and added a raft of improvements for a better Action Management useability. These improvements provide additional flexibility when Actions are triggered and better creation/editing of the Action Rules. New filters give you greater control on how you track and manage Actions.



EnviroSys mobile updates

The EnviroSys mobile app was updated in April and moved over to acQuire Technology Solutions' app stores. The new version, 3.1, includes improvements to data entry forms, Azure API Proxy integration plus general performance improvements and bug fixes to deliver a better app experience for you.
